## **PURPOSE**

BC Financial Services Authority is updating B.C. credit union peer groups in the Integrated Regulatory Information System ("IRIS"). Gulf and Fraser Fishermen's Credit Union has been moved from peer group 6 to peer group 5. These updates will be effective in the Credit Union Performance ("CUP") Report during the week of February 5, 2024.
