| Disclosure Statements & | Disclosure Statement Amendments | |
| "Disclosure Statement (New Development)" | This submission is used to submit a Disclosure Statement under the <i>Real Estate Development Marketing Act</i> when the developer does not have an existing BCFSA file number for this development or has not previously created this development in IRIS. | |
| "Disclosure Statement (Development Already in IRIS)" | This submission is used to submit a Disclosure Statement to BCFSA under the <i>Real Estate Development Marketing Act</i> if the developer has an existing BCFSA file number for this development or has previously created this development in IRIS. | |
| "Section 15.1 Phase Disclosure Statement (Development Already in IRIS)" | This submission is used to submit a subsequent section 15.1 Phase Disclosure Statement (i.e. separate disclosure statements for each development phase) to BCFSA under the <i>Real Estate Development Marketing Act</i> . | |
| | If you are submitting your first section 15.1 Phase Disclosure Statement, you should use the "Disclosure Statement (New Development)" submission. | |
| | Only use this if the developer has an existing BCFSA file number for this development and has previously filed a Phase Disclosure Statement as described in section 15.1 of the <i>Real Estate Development Marketing Act.</i> | |
| "Disclosure Statement Amendment" | This submission is used to submit a Disclosure Statement Amendment under the <i>Real Estate Development Marketing Act.</i> | |

| "Strata Forms (Form V, Form W)" | This submission is used to submit forms (Form Vs and/or Form Ws) that require approval by the Superintendent of Real Estate under the <i>Strata Property Act</i> . | |

| "Exemption Application (New Development)" | This submission is used to submit a section 20 exemption request (other than for the <u>Early Marketing Pilot Program for Large Developments</u>) under the <i>Real Estate Development Marketing Act</i> when the developer does not have an existing BCFSA file number for this development or has not previously created this development in IRIS. | |
| "Exemption Application (Development Already in IRIS)" | This submission is used to submit a section 20 exemption request (other than for the <u>Early Marketing Pilot Program for Large Developments</u>) under the <i>Real Estate Development Marketing Act</i> when the developer has an existing BCFSA file number for this development or has previously created this development in IRIS. | |

| "Document Revision" | This submission is used to submit a revised version of a document previously submitted (e.g. in response to a deficiency or if an error was noted by the developer prior to BCFSA's review). | |

| "Additional Information" | This submission is used to submit any additional information or documents that the developer would like to submit to BCFSA or that BCFSA has requested from the developer. | |
