

Revision to Peer Groups Reporting

PURPOSE

BC Financial Services Authority (BCFSA) is modifying the way peer groups are reported in the Integrated Regulatory Information System (IRIS). As the number of credit unions in B.C. continues to decline due to mergers, these modifications are intended to maintain the confidentiality of reporting credit unions.

BACKGROUND

Currently, peer groups are reported individually. Moving forward, results for peer groups 2 and 3 will be combined, as will results for peer groups 4 and 6. For example, instead of separate columns for peer groups 2 and 3 in the Credit Union Performance (CUP) Report, a single column will display the combined results

These changes will take effect in the CUP Report during the week of December 8, 2025.

A summary of the revised reporting peer groups is provided below, with further details available in the Appendix.
